# Call for projects Tango & Scan 2024

#### **BACKGROUND AND OBJECTIVES**

The Tango&Scan call for innovative projects has been subsidising innovations in the Strasbourg Eurometropole area for over 10 years now. As part of the *Pacte pour une économie locale et solidaire* (Pact for a local and inclusive economy), the Eurometropole is promoting economic and ecological development by encouraging the emergence of a local ecosystem and supporting local stakeholders.

Subsidised by the Eurométropole de Strasbourg to the tune of €250,000 and run by the organisation **accro**, Tango&Scan aims to support the emergence of innovative products and services by bringing together a project leader and a partner, providing support for the project in stages and a financial grant of up to €20,000.

accro is the point of contact for any project owner wishing to respond to the call for projects, and is available to help them submit their application. As part of the France 2030 programme, the 2024 edition of Tango&Scan will be focusing on projects that promote Artificial Intelligence. However, it is not mandatory to submit an Al-related project in order to apply for Tango&Scan 2024. Applications will open in Spring 2024.

#### THE GRANT

The amount of the grant awarded is a maximum of 50% of the total cost of the project declared in the budget, but may not exceed € 20,000.

The project leader undertakes to make a financial contribution to the project with no minimum fee. The partner undertakes to provide a financial contribution to the project. This financial contribution must represent at least 20% of the Tango&Scan endowment requested and may be in the form of a financial contribution and/or in the form of work time. The grant is paid to the project leader (and not to the partner) in two instalments:

 → 70% of the grant as soon as the contract is signed;
→ 30% after a report on final implementation,

and on proof of expenditure incurred.

The Strasbourg Eurometropole reserves the right to demand full reimbursement of the grant, or not to pay the 30% left, if the project is not completed by 1 April 2025.

## **ELIGIBILITY REQUIREMENTS**

The call for projects encourages economic development and stimulates innovation by promoting meetings, skill transfer and cross-fertilisation around a common project between:

## → A stakeholder in the creative and/or digital sector on the one hand → A stakeholder from another economic sector, on the other hand

The project owner must be a company, a self-employed entrepreneur, an organisation, a craftsperson, an artist or a student entrepreneur; from the creative and cultural industries or digital companies.

The project leader must be domiciled in the Eurometropole of Strasbourg. The partner can be anywhere in the world. Each project leader or partner may submit only one application per edition of the call for projects, but two partners may finance the same project.

In order to guarantee a renewal of the award-winners, each prize-winner (project leader and partner) may not be a prize-winner more than twice in any consecutive three-year period.
